- Key Information Needed:
    - Date, Time, Division, Court, Partner names, Team names, Player numbers/names, Description of Incident, Team Colours
  - Use proper FIBA terminology (i.e., we do not have ejections; we have disqualifications)
  - Encouraged to review disqualification rules in rulebook (payers cannot stay on the court if disqualified)
  - Meeting coming up with EBA to discuss incidents and clarifying warm-up times and procedure for players who are disqualified.
- b. Assigning Calendar (V. Eshenko)**
- 252 active officials who have handed in registrations and have attended clinic. 37 still not ready to referee in Arbiter.
  - 61 additional officials still on roster from last year – most community officials
  - Sept 1 to Oct 13 560 games assigned including Community and EBA
  - over 450 declines – 40% of assignment
  - update calendar on daily
  - intramurals and high school starting
  - NOCP levels posted on Profile sheet as well as Arbiter leveling
  - L. Mangano to distribute breakdown of game expectations based on Arbiter leveling.
  - 2 weeks in advance for assigning High School games
- c. Education & Development (J. Irvine)**
- i) Makeup clinic
    - First makeup clinic this past weekend
    - One more makeup clinic – weekend of December 1<sup>st</sup> and 2<sup>nd</sup>
    - Must attend a clinic by Dec 2<sup>nd</sup> to officiate
  - ii) Rule clarification
    - No changes to floor markings (not using the further 3-point line or no block/charge semi-circle)
    - Use EBA modifications
    - Those reffing ACAC cannot wear T-shirts with sleeves under uniforms
    - Either team violation during a free throw, shooter violation takes precedent
    - Rule mods on CABO website
    - Rough post play is a point of emphasis.
  - iii) Exam Preparation
    - November 15<sup>th</sup> to December 15<sup>th</sup>
    - Quizzes to be posted tonight and weekly basis along with answers
    - Minimum mark is 65%; provincial 80%; national tournament 86%

    - Must submit 5 choices

- ACAC:

  - Email ACAC game reports to J. Irvine
  - After women’s game, 23 minutes go up on the clock once floor is cleared.
  - Standardized form for incidents being worked on.
  
- Fighting
  - Don’t get in middle.
  - Take notes, stay with partner.
  - Get teammates to control the situation.
  - Our responsibility to keep the court safe. Why did the fight start?
  
- Community League (F. Goldring)
  - 6 officials selected to evaluate
  - 14 new people and 38 community league for a total of 52; last year we had 112
  - Only 26 of 56 people worked this past weekend
  - Seasoned officials encouraged to work with new officials for proper mechanics and positioning
  - Clinic being put on by St. Albert. Another clinic at the Butterdome; not EBOA affiliated (to be posted)
  - Community games are cash to be collected before games. Prices are reflected by your games on Arbiter.
